2025/2018: Change of use of buildings and yard for agricultural storage, vehicle/equipment hire, sales & servicing centre to storage and distribution use (Class B8)

OPC has responded to this application, asking for clarification as to what this application is for, as the planning statement is not clear.

The Chair has contacted the case officer who had not heard back from the applicants and will chase them for a response. One document online from the agents seems to indicate that the former agricultural sales and repair business has left the site.

OPC concerned about the type of and numbers of traffic this site will generate and that it is a more industrial use than agricultural.

2025/2663 Scoping Opinion for an Anaerobic Digester/ 2025/1631 Screening Opinion OPC were informed by the Chair that there have been responses from consultees asking for some additional information to be provided when the planning application is submitted. The feedstock satellite clamp locations are still not clear and are not included in the current information. At this stage it was agreed to make no further comment, unless there is a need to. OPC had prior to the meeting responded to the Screening opinion 2025/1631with concerns over traffic and the industrial nature of the proposal.

2025/2689 Non-Material amendment to 2024/1261 (1) The removal of the consented inverter cabins (2) Amend the layout to recognise new internal access points (3) Upgrade the two consented transformer substations and (4) Operations and Maintenance building (container)

This application is to change some of the equipment on the Phase 2 airfield solar farm site as there has been a need to update equipment since the application was granted in 2015.

Other planning items

Paul Killingback noted that one of the agricultural barns at **Street Farm** (near to the exit) appears to be in the process of being dismantled. This may have something to do with a new building which was granted permitted development, (**2025/2339**) **Proposed agricultural general building**
