(i). Planning applications received before 30th July 2025 and any updates PP-14044888 2025/2018

The Hanger, Heydon Road, Cawston

Change of use of buildings and yard for agricultural storage, vehicle/equipment hire, sales & servicing center to storage and distribution use (Class B8) No objection

(ii). To receive Offshore wind updates

Residents have notice more activity in the compound/accesses of Blickling Rd this is between MA7/MA8 compounds. The Chair has emailed Murphy's for more information. RWE are holding public information days in Reepham Town Hall on 5th August 9-12pm and in Aylsham Market place on 22nd August 8-12pm.

(iii). To receive Solar Farm update

No further information has been received from the phase 2 airfield Solar farm or Bluestone Solar about when construction will be carried out.

(iv). Anaerobic Digester updates/screening opinion BDC 2025/1631

OPC had invited the applicants (**Bluestone Biogas**) to the 30th July meeting, however they have declined to attend at this time as they are still in the process of gathering further information following the exhibition feedback.

The EIA decision is also delayed as the applicants were wishing to submit further information, but OPC has now been told by planning and the applicant, that a decision should be made on the 6th August.

Alison Shaw and Susan Mather attended an informal meeting with NCC Highways, in Oulton on 8th July, along with representatives from Itteringham PC and Cawston PC to discuss potential impacts from the AD proposal. The main concern was the 15 radius from the AD site in Oulton for the growing and harvesting of energy crop feedstock, the delivery of 50,000 tonnes to the AD and the remaining 100,000 tonnes to any satellite clamps. It was agreed that there was a need to know where these clamps would be located in any planning application.

It was a constructive meeting and notes were taken and shared with all PC's.

Alison Shaw and Susan Mather also attended a meeting with the case office at BDC/S Norfolk Planning department on 22nd July, to discuss OPC's planning concerns. It was again a constructive meeting and all agreed that until a planning application was submitted it was hard to answer all of our queries.

On further reading of the screening opinion letter, it was noted by the Chair that the satellite clamps may also need to contain a digestate lagoon, as the digestate has to be stored and only used on land at specific times of the year, this is due to this area being in a Nitrate Vulnerable Zone (NVZ). It is noted that about 70% of the digestate created from the AD process would be liquid.
